Unf. Bus.) The complaints of the Brothers Wolfson and Grossman were reviewed. It was decided that no complaints about personal misfortune are welcome and the situation will no longer be dealt with – from before or after this meeting. Brother Wolfson's request was accepted. The \$50 for the cemetery will be paid by the next meeting or within a month.

New Bus.) Nomination of officers – It was decided that the organization should carry out all the decisions and ideals. The butcher Mr. Weissumeser paid \$7 to the society for the shochet. Half of the \$7 was designated for the shochet Mr. Rezits. The butcher Weissumeser was involved in an argument, which he mentioned to the society. Mr. Morris Leshem recommended regarding the same argument that the condition would be that that the butcher would give over \$28 to the society for six months as security. \$4 would be payment for the shochet. Mr. Morris Leshem will pay the salary of the shochet every week, and the society will ensure that the shochet will be paid. It was decided that the organization will pay the shochet \$7 a week. It was decided that a new butcher would run the butcher shop. He should pay Mr. Leshem for upholding the butcher shop, and the shochet \$7 a week. And it was decided that the organization will no longer have anything to do with the butcher shop. Brother Leshem had retained the security of \$28. In total, there was \$13.85 in the treasury on February 25.

A vote was taken regarding the new member Mr. Joe Rosenberg and he was elected through the negligence of two committee people from among the five who had not helped in examining the account books of the financial status of the organization. To continue the progress, all the members were present for the reading of the business of the sick benefit by Brother Silverman so that they will know about the books and finances.

Brother and secretary Hoch returned home from a journey. He spoke to the organization about the need to elect officers. Nominations were read out. A motion proposed by Brother Korngold that the communications should be open was read out. 50 cents was paid to the shamash [administrator] for calling the meeting, and 8 cents for postage stamps.

The minutes of the previous meeting were read and accepted. A plan regarding the cemetery was read and accepted. A question was discussed regarding the need for \$80 to be sent to Messrs. Lovergrove and Taka in Philadelphia for the sign and the machine for the mikvah – whether or not it will be on the accounts of the organization. It was determined with the authority of the organization that all of the machines in the mikvah indeed belong to the same organization. This was accepted.

A dead person was brought in through the auspices of a Jew from Wilmington who made the request and paid for the grave. It was decided that no dead person whom someone knows should be brought in without first informing the president or the shamash. The room on 211 Market Street will be rented to several societies. Also, 45 chairs will be rented along with the room.

Regarding the sick benefit for Brother Silverman, the finance committee determined that a fine will not be imposed. It was decided to take back \$3.27 from Brother Gordon that was designated for the half shekel for Purim. It had been given to him through the mikvah. Brother Gordon is to give over the \$3.27 to the organization through the shamash. Sklut and treasurer Fogel. They were thanked for their expenditures. Misheberach money in the amount of \$30.10 was designated for the mikvah. It is to be given to Brother Gordon, the treasurer of the mikvah, when it will be ready.

The regular meeting of the Adas Kodesh Knesset Yisrael Society took place under the chairmanship of the president Brother Gluck and the vice president Brother Sklut.

The minutes of the previous meeting were read and adopted. A bill for \$4.50 was given over by Brother Grossman of which \$2.50 was for moving the furniture from the former synagogue room. The remaining \$2.00 was for the work done by Brother Handelman. This was read, and it was decided that the \$2.00 for Mr. Handelman's work would be paid by the "Open committee" that oversees the work that everybody does. In the meantime, it will be put to a decision at the next meeting.

The committee of trustees presented its annual report. The income from March 1891 until March 1892 was \$506.20. \$510.09 remains as the balance to pay the ex-treasurer Brother Blumberg. \$3.89 was taken.

It was decided that the president will call a general meeting to create a contract with Brother Handleman for his living quarters in the mikvah premises.

A two-person committee consisting of Brother Reissman and Brother Fogel was designated to move the remaining furniture from the old synagogue. The society will pay the expenses. The business regarding Brother Silberman will be concluded at the next meeting.

A special meeting was called today, chaired by the president Brother Gluck regarding the business or an agreement that was demanded from the society by Brother Handelman. It was related to the dispatch. Finally, it was decided to make an agreement and the matter was closed. It was decided that Mr. Handelman should help pay the water tax.

"The undersigned willingly permit Mr. Bernard Handelman 4 rooms, 3 on the 2^{nd} story and 1 room on the 3^{rd} story, as a dwelling place. The bottom story will serve as a fully usable Mikva with 4 baths. It will belong to the Chevra Adas Kodesh Knesset Yisrael society. The rent will be \$144.00 for a year, from March 25, 1892 until March 25, 1893 in monthly installments of \$12 on the 25^{th} of every month. Mr. Handelman will maintain the mikvah and baths with his own money. He will rent out the mikvah and the baths to Jewish women. He will charge no more and no less than 50¢ to women who use the mikvah, and 15¢ for men and women to use the baths [2]. A man must pay 15¢ to use the bath or the mikvah in the middle of the week. They will prepay for immersion on festivals. The mikvah and the baths will be closed on the Sabbath. Any woman who needs the mikvah must inform Mrs. Handelman between 12 and 2 in the afternoon on the day that she intends to come. Mr. Handelman is allowed to permit gentiles to use the baths. Mr. Handelman must undertake to make any repairs to the machinery that may come up throughout the year. Mr. Handelman must pay any expenses up to \$3. The society agrees to all of this."

TRANSLATOR'S NOTES

- 1. Here referring to the services of a caretaker.
- 2. Women who require the mikvah would only do so at night. Men who wish to use the mikvah for purity purposes (non-obligatory, but customary among Hassidim in particular) would do so during the day. The woman's obligatory preparations prior to the monthly ritual immersion in the mikvah are quite extensive, and a female mikvah supervisor is generally present to ensure proper immersion, hence the higher fee. The proportion of the fees are in-line with modern times (In Toronto, current rates are \$17 for women, and \$5 for men).
- 3. This word is written in English (unclear if it is Leo, Lea, or Lei), followed by the transliteration in Hebrew / Yiddish letters in quotation marks (same possibilities). There is a street in Wilmington called Lea (East and West Lea. In the next paragraph, Chester is a nearby town northeast of Wilmington. On page 41, Lea is referred to as a butcher, also in quotes perhaps referring to the street of the butcher shop.
- 4. Some of the last few words are unclear due to the last line on page 43 being truncated.
- 5. Not sure of this word, but could mean to be excluded from participation from the society.
